




#### **Hangar Stack Options**


- The business jet hangar can accommodate a variety of mid, supermid, and large cabin stacking arrangements.
- Bi-fold door spans the near width of the hangar (87.5') providing maximum flexibility and stacking efficiency.
- Roll up / tug escape vehicle door accommodates nose-in stacking arrangements.
- Heated apron allows for safe egress/ingress in winter-time climate.




